Annual District Minutes

March 6, 2018

The meeting was called to order at 6 pm by the moderator, Richard Judd. He explained how the meeting would be conducted and the procedures to be followed. There were approximately 75 voters in attendance.

1. To determine the salaries of the School Board and fix the compensation of any other officers or agents of the District. These salaries are included in Article 04.

Arnold Gray made a motion, seconded by Bev Martin, to set the salaries same as those of the town officers.

The Motion Carried and Article 1 passed.

Richard Sargent made a motion seconded by Richard Lapoint, to restrict reconsideration of article 3. The motion carried and reconsideration is restricted.

2. To hear the reports of Agents, Auditors, Committees or Officers chosen and pass any vote relating thereto.

Nicole Jeralds made a motion, seconded by Pat Phillips, to accept the reports as printed in the school report.

The Motion Carried and Article 2 passed.

Richard Sargent made a motion seconded by Tammy Jeralds, to restrict reconsideration of article 2. The motion carried and reconsideration is restricted

3. To see if the School District will vote to raise and appropriate the sum of seventy thousand, one hundred and twenty four dollars (\$70,124) to purchase a new school bus and authorize the withdrawal of seventy thousand, one hundred and twenty four dollars (\$70,124) from the expendable trust fund created for that purpose. The school board recommends this appropriation.

Julie Bolton made a motion, seconded by Pat Phillips to accept article as it was read.

The Motion Carried and Article 3 passed.

Richard Sargent made a motion seconded by Tammy Jeralds, to restrict reconsideration of article 3. The motion carried and reconsideration is restricted.

4. To see if the School District will vote to raise and appropriate the sum of two million, nine hundred seventy five thousand eight hundred twenty three dollars, (\$2,975,823.00) for the support of schools, for the payment of salaries for the school district officials and agents, and for the payment for the statutory obligations of the District. This article does not include appropriations voted in any of the other warrant articles. The School Board recommends this appropriation. (Majority vote required)

Bridger Dewitt made a motion, seconded by Tammy Jeralds, to accept article as read.

The motion Carried and Article 4 passed.

Bev Lord made a motion, seconded by Bev Martin, to restrict reconsideration of article 4. The motion carried and reconsideration is restricted.

5. To transact any other business that may legally come before this meeting.

The recommendation was made by the town's people to form a committee for looking at consolidation and working with other area schools.
